







Applications for the 75% Emergency Wage Subsidy are now open. Eligible businesses will be able to receive a subsidy of 75% of employee wages for up to 12 weeks, retroactive from March 15, 2020, to June 6, 2020.





Free TIAO Membership For The Tourism Industry In 2020




Stakeholder Consultations




Ad Credits For Google Ads Small And Medium-sized Businesses

HOW TO APPLY FOR THE CANADA EMERGENCY RESPONSE BENEFIT



WHAT IS CERB AND WHO IS ELIGIBLE?

CERB is a temporary income support for workers who have ceased working due to COVID-19. It provides a flat benefit of \$2,000 for a 4-week period for workers who have been out of work for 14 consecutive days in any four-week period for reasons relating to COVID-19. Eligibility is as followed: (check the very latest criteria here)

- Those who live in Canada and are over 15 years old.
- Those who have lost their job because of COVID-19 or are eligible for EI or sickness benefits or have exhausted their EI benefits between December 29, 2019 and October 3, 2020.
- Those who had employment and/or self-employment income of at least \$1,000 in 2019 or in the 12 months prior to the application; & who have not quit their job voluntarily.
- Those who earn less than \$1000 a month.



WHEN TO APPLY

Apply on the day corresponding to the month you were born



Monday: Jan, Feb or Mar Tuesday: Apr, May & Jun Wednesday: Jul, Aug & Sept Thursday: Oct, Nov & Dec Friday, Saturday & Sunday: Anyone can apply.

Apply online: You can apply via your CRA account or if you are not registered, have forgotten your password or have an existing Service Canada account click here and read step 1 for instructions.



WHAT HAPPENS NEXT?

Confirm your details and hit apply. If you sign up for direct deposit you will recive your funds in 3 days or a cheque within 10 days. **You will need to repeat this process every four weeks**.


